• At the last trustees meeting it was reported that SALS found a discrepancy between our charter and by-laws. The charter indicates that a trustee's term is three years while the by-laws state that the term is five years. The trustees recommend that the charter be amended to match the by-laws. This involves some paperwork and a fee of \$60. Maggie McDonough made a motion to approve the \$60 payment. It was seconded by Lydia Hoffman and passed with one opposed vote and 0 abstentions. Rachel Ziegler Sheridan and Courtney Max were asked by the board to work with the Department of Education on this task.
